ABSTRACT

S. Harry Robertson has worked in the fields of aviation safety, safety research, accident investigation, and in the design and production of crashworthy, ballistically tolerant fuel systems used by military aircraft worldwide. The Robertson Papers contains accident investigation case files (including over 15,000 photographs); technical papers, reports, and reference material; a video library; and books and periodicals.
